- PLEASE ENSURE THAT AN IMPORT PERMIT IS OBTAINED PRIOR TO THE SHIPMENT OF CONSIGNMENT

PRODUCTS OF ANIMAL ORIGIN

- ALL PRODUCTS OF ANIMAL ORIGIN MUST BE COMMERCIALY PACKAGED AND LABELLED
- ENSURE THAT THE COUNTRY OF ORIGIN IS IDENTIFIED IF SUPPLIER COUNTRY DIFFERS
- PLEASE ENSURE THAT AN IMPORT PERMIT IS OBTAINED PRIOR TO THE SHIPMENT OF YOUR GOODS
